"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs,

Township, on Clayton Street in the City of Greer, having the following courses and distances, to wit:

Beginning on a stake on the north edge of a new street, corner of lot now or formerly belonging to Grady L. Webb, and running thence up the branch, N. 35.18 W. 161 feet to a point in branch (stake on west side of branch on next line at 10 feet); thence with the B.L. Colvin line, S. 70.25 W. 102 feet to an iron pin by fence post, corner of B.L. Colvin property and other property of Troy R.
