NOW, KNOW ALL MEN, that first party, in consideration of the indebtedness as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell, and release, in fee simple, unto second party, its successors and assigns, the following described lands, to wit:

All that piece, parcel and tract of land lying and being in Grove Township, Creenville County, South Carolina, lying on both sides of the fork Shoals Road, about 12 miles from Greenville, containing One Hundred Twenty Seven and 30/100 (127.30) acres, more or less, according to survey and plat made by W. J.Riddle, dated September 17, 1934, and revised on June 17, 1939. It is bounded by lands now or formerly of J.D. Chandler and Maggie Holcombe on the North, Maggie Holcombe on the East, Junius Garrison, J. K. Huff and the fellowship Church lands, on the South and S. B. Huff and J.T. Childers on the west, with it being distinctly understood that the rectangular parcel of land lying in the fork of the forks Shoals Road and the Georgia Road and designated on the plat as "Fellowship Church" lands is excluded herefrom and it is also understood that the rectangular parcel lying to the North of but not adjoining the Fellowship Church lands is likewise excluded herefrom, it being known as the "gin lot". ALSO: All that piece, parcel and tract of land lying in Grove Township, Greenville County, South Carolina, containing One Hundred Ninety Five and 25/100 (195.25) acres, more or less, according to survey and plat made by J.Mac Richardson, Land Surveyor, in May 1949, and bounded on the North by Junius Garrison, on the East by Junius Garrison and C. O. Perry, on the South by C. O. Perry and on the West by Mr. Black and Junius Garrison. It is the same parcel of land conveyed to Paul K. Thackston by Mrs. Corrie Bozeman by deed deted Janu ry 13, 1938, recorded in Deed Book 201, Page 402. The Richardson plat fully described the land by courses and distances and metes and bounds and is recorded in Pl t Book V, Page 159, R. M.C. Office for Greenville County, and reference is here made thereto for a more definite and particular description.
