Township, containing one acre, more or less, being situate at the most westerly corner of tract of land of Waymon Chastain and also being situate on the north side of the Buncombe Road and on the east or southeast side of a County Road and being more particularly described as follows:

"BEGINNING at a stake at a culvert, the most westerly corner of land of Waymon Chastain and running thence with the center line of the County Road, N. 32-1/2 E. 147 feet to a stake; thence still with the center line of said County Road, N. 62 E. 84.5 feet to a stake; thence with line of Waymon Chastain, S. 46-27 E. 170 feet to a stake; thence with line of Waymon Chastain, S. 23-38 W. 190 feet to a stake on the north side of the Buncombe Road; thence with said road, N. 57-38 W. 237.9 feet to the beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to the New Liberty Baptist Church by Waymon Chastain by deed dated March 31, 1948 and recorded in the R. M. C. office for Greenville County in Vol. 341, at page 329."
