"BEGINNING at an iron pin on the northeastern side of Harvard Avenue, said pin being 200.8 feet south of the intersection of Harvard Avenue and the Old Easley Bridge Road, and running thence N. 28-44 E. 160.1 feet to an iron pin in a ditch (being the joint rear corner of Lots 60 and 61 according to Plat Book M, at page 85); thence S. 60-51 E. 60 feet to an iron pin in ditch; thence S. 28-44 W. 160.1 feet to an iron pin on the northeastern side of Harvard Avenue; thence with Harvard Avenue, N. 60-51 W. 60 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
