MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, J. Ralton Shirley and Belle R. Shirley, of Greenville County, SEND GREETINGS:

WHEREAS, we the said J. Ralton Shirley and Belle R. Shirley

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the

full and just sum of Seven Thousand, Seven Hundred and No/100 - - - (\$ 7,700.00 )

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of

Sixty-Four and No/100 - - - - - (\$ 64.00 ) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That we, the said J. Ralton Shirley and Belle R. Shirley

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to us,

the said J. Ralton Shirley and Belle R. Shirley in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being known and designated as Lots 8 and 9 of Block "C" of Pinehurst, shown on a plat thereof by W. N. Willis, Engineer, October 28, 1948, recorded in the R. M. C. office for Greenville County in Plat Book "S" at page 77, and according to said plat, having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Northeast side of Pinehurst Drive, which pin is located 478.7 feet from the Northeast corner of the intersection of Lee Road and Pinehurst Drive, and running thence with the joint lines of Lots 7 and 8, N. 62-23 E. 141.6 feet to an iron pin; thence S. 25-28 E. 120 feet to an iron pin, joint rear corner of Lots 9 and 10; thence with the joint line of Lots 9 and 10, S. 62-23 W. 139.9 feet to an iron pin on the northeast side of Pinehurst Drive; thence along Pinehurst Drive, N. 26-48 W. 120 feet to an iron pin, the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same conveyed to us by Charles Crain and Louise Crain by deed dated Mar. 9, 1954 and recorded in the R. M. C. office for Greenville County in Vol. 496, at page 87."
