All that lot of land with the buildings and improvements thereon, in Greenville County, South Carolina, located on the Northeastern side of White Horse Road and lying in the triangle between that road and Pendleton Road, and is shown on Plat of Property of Mrs. Lula B. Thruston dated April 5, 1953, made by C. C. Jones, on which it is designated as Lot No. 6. From that plat the following description is taken:

BEGINNING at the joint front corner of Lots Nos. 5 and 6 on the Northeastern edge of White Horse Road and running thence the joint line between those lots N. 51-05 E. 113.4 feet to their joint rear corner with Lot No. 9; thence the joint line between Lots Nos. 6, 9 and 10 S. 49-11 E. 100 feet to a point in line with Lot No. 10, which constitutes the joint rear corner between Lots Nos. 6 and 7; thence the joint line between these lots S. 54-34 W. 135.5 feet to their joint front corner on the Northeastern edge of White Horse Road; thence this edge of said hoad N. 36-07 W. 90 feet to the beginning corner.
