F.L. Crow and his heirs and assigns:

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying and being on the West side of Morrow Street, being designated as Lot No. 28 in a resurvey and re-subdivision of a portion of Morrow Heights, made by H. S. Brockman, Surveyor, dated September, 1935, (said plat and survey made for R. D. Dobson Estate), which plat is on record in the R. M. C. Office for Greenville County, having the following courses and distances:

BEGINNING on a stake on the western margin of Morrow Street, the joint corner of Lots 27 and 28, and runs thence with the common line of Lots 27 and 28 N. 78.51 W. 155.1 feet to a stake; thence S. 11.47 W. 69.2 feet to a stake; thence S. 77.49 E. 155.1 feet to a stake on the western margin of Morrow Street; thence along the line of Morrow Street N. 11.45 E. 72 feet to the beginning corner.
