NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Dellwood Drive in the City of Greenville, being shown as Lot No. 122 on plat of property of Central Development Corporation, recorded in Plat Book BB at Page 23, and described as follows:

"BEGINNING at a stake on the southern side of Dellwood Drive at corner of Lot No. 121 and running thence with the line of said lot S. 12-53 W. 191.2 feet to a stake in line of Lot 116; thence with the line of Lots 116 and 115 S. 73-02 F. 80 feet to a stake at corner of Lot 123; thence with the line of said lot N. 13-13 E. 195.9 feet to a stake on Dellwood Drive; thence with the southern side of said Drive N. 76-26 W. 80 feet to the beginning corner."
