All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, lying on the west side of State Highway No. 14, about two and one-half miles North from the City of Greer, and also lying on the Northwest side of the Ansel School Road, being all of Tracts Nos. 2 and 6 on plat of property made for E. R. Minus, Jr., and G. Ha Waters, Jr., by H. S. Brockman, Surveyor, dated November 24, 1947, and having the following courses and distances:

## Tract No. 2 as follows:

BEGINNING AT a point in center of Mosteller Road, Highway No. 14 and runs thence with said road West 100 feet to corner of lot No. 1, in Hwy. 14 thence S. 61-06 W. 296 Ft. to an iron pin, corner of Lot 1, thence S. 45-15 E. 267 ft. to iron pin on west bank of Ansel School Road; thence with said road N. 27-00 E. 277 ft. to beginning corner, and containing 1.21 Acres.
