NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being nown and designated as lot # 10, as shown on a plat of Davis Property, Eastover, recorded in Plat Book AA at Page 123, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the Southwest side of Beechwood Avenue, at the joint front corner of lots 10 and 11, which pin is 67.3 feet Southeast of the intersection of Beechwood Avenue and Haviland Avenue and running thence with Beechwood Avenue, S. 29-23 E. 67.3 feet to an iron pin, corner of lot 9; thence with line of said lot, S. 55-47 W. 132.85 feet to an iron pin in line of lot now or formerly owned by B.
