"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the Southeast side of Furman Road (also known as Bates Street Extension) being known and designated as Lots 2, 3, 4, 5 and an unnumbered parcel, as shown on a plat of Newlands, recorded in the R. M. C. office for Greenville County, S. C. in Plat Book "C", at page 199, and being described according to said plat and according to a more recent plat prepared by Piedmont Engineering Service entitled "Property of Wilkins Burns, near Greenville, S. C." and having, according to said plats, the following metes and bounds, courses and distances, to-wit:

"BEGINNING at an iron pin on the Southeastern side of Furman Road (also known as Bates Street Extension), which iron pin is 90 feet in a southwesterly direction from the intersection of Furman Road and Old Paris Mountain Road, and running thence S. 8-32 E. 150 feet to an iron pin; thence S. 61-30 W. 110.0 feet to an iron pin; thence N. 8-32 W. 150 feet to an iron pin on the southeastern side of Furman Road, thence along the Southeastern side of Furman Road, N. 61-30 E. 110.0 feet to an iron pin, the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
