"BEGINNING at an iron pin on the northern side of Heatherly Drive in the front line of Lot No. 4 as shown on the J. O. Heatherly plat hereinabove referred to, and running thence along the northern side of Heatherly Drive, S. 68-30 E. 90 feet, more or less, to an iron pin in the front line of Lot No. 5, said Heatherly plat; thence N. 28-20 E. 131.5 feet to an iron pin; thence N. 68-30 W. 66.8 feet to an iron pin (this corner being located on the joint line of Lots Nos. 3 and 4); thence N. 61-30 W. 19.2 feet to an iron pin; thence S. 29-45 W. 133.2 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to me by Fay L. H. Riddle by deed dated July 23, 1954 and recorded in the R. M. C. office for Greenville County in Vol. 504, at page 495."
