NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeast corner of the intersection of Claremore Avenue and Highland Drive, in the City of Greenville, being shown as Lot No. 32, Block I, Section 5, on plat of East Highlands Estates, made by Dalton & Neves, Engineers, February 1941, recorded in the R. M. C. office for Greenville County in Plat Book K, at pages 79 and 80, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeast side of Claremore Avenue, at joint front corner of Lots 31 and 32 of Block I, and running thence along the line of Lot 31, N. 34-46 E. 157.7 feet to an iron pin; thence with the line of Lot 33, N. 61-22 W. 120 feet to an iron pin on the east side of Highland Drive; thence with the east side of Highland Drive, S. 15-31 W. 110 feet to an iron pin; thence with the curve of Highland Drive and Claremore Avenue (the chord being S. 18-30 E. 66.4 feet) to an iron pin on the northeast side of Claremore Avenue; thence with the northeast side of Claremore Avenue, S. 52-29 E. 30 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same property conveyed to me by David W. Balentine by deed of even date herewith, not yet recorded."
