"All the certain piece/parce! or lot of land, with all improvements thereon, or hereafter constructed the constitute, lying and being in the State of South Carolina, County of Greenville, at the Northwestern conner of Grove and Judson Streets, in the City of Greenville, being shown as lots Nos.

2, 3 and 4 on plat of the property of S. B. McDaniel, recorded in Flat Book E at large 129 and described as follows:
