That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, on Duckworth Road, at River Falls, known and designated as Lot No. 21 of a sub-division of the land of D. B. Tripp at River Falls, as per a plat made by W. A. Hester, Surveyor, on April 21, 1926, recorded in the R. M.C. Office for said County and State in Plat Book "G" at page 89, and said lot having a frontage of approximately 70 feet and a depth on the South of 140 feet and on the North 150 feet, both running back to the branch, for a more particular description, reference of the said plat is herein made, and being the same lot of land conveyed to Ella R. Batson harmin by John W. and Annie S. Johnson by Deed dated February 26, 1953, recorded in the R.M.C. Office for said County and State in Deed Book 473, at page 268.

This property is conveyed subject to the following restrictions: The property is not to be used for business purposes but shall be used for residential purposes for white people only (this not to apply to servants); no hogs shall be kept on said property and no sewage shall be imptied into any creek.
