J.C. Bruce and his heirs and assigns:

All that certain parcel or lot of land situated on the west side of Forest Street and north of the Dual-lane Highway, near the limits of the City of Greer and northward therefrom, in Chick Springs Township, Greenville County, State of South Carolina, being designated as Lot No. 60 of the Property of Geanie L. Caldwell according to survey and plat thereof by H.L. Dunahoo, Surveyor, recorded in Plat Book "X", page 1, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:
