NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, being known and designated as Lot No. 54 according to a plat of Belmont Heights prepared for Local Home Builders, Inc. by C. C. Jones, C. E., April, 1954, said plat at this time being unrecorded, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Cool Brook Drive, joint front corner of Lots 53 and 54, and running thence with the joint line of said lots, S. 64-26 W. 171 feet to an iron pin; thence continuing with the joint line of said lots, S. 64-26 W. 5 feet to a point in the center of a branch; thence with the meanderings of said branch, the traverse lines of which are S. 3-06 W. 40.8 feet to an iron pin; thence S. 56-45 E. 40 feet to an iron pin, joint rear corner of Lots 54 and 55; thence leaving said branch and running with the joint line of Lots 54 and 55, N. 64-26 E. 170 feet to an iron pin on the western side of Cool Brook Drive; thence with said drive, N. 24-34 W. 70 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
