WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-four Hundred and No/100 - - - -

DOLLARS (\$ 4400.00), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side of F fth Avenue in Section #2 of Jud on Mills Village, being known and designated as lot #57 as shown on plat of Sec. 2 of Judson Mills Village, made by Dalton & Neves in November 1939, recorded in Plat Book K at Page 25, and described as follows:

"BEGINNING at an iron pin on the western side of Fifth Avenue, joint front corner of lots Nos. 57 and 58, said pin being 80.6 feet north from the northwest corner of the intersection of Fifth Avenue and Sixth Street and running thence with joint lines of lots Nos. 57 and 58, N. 85-53 W. 277.5 feet to an iron pin; thence N. 10-16 W. 83.3 feet to an iron pin; thence with the joint line of lots Nos. 56 and 57, S. 83-53 E. 300.9 feet to an iron pin on the western side of Fifth Avenue, joint front corner of Lots Nos. 56 and 57; thence along the western side of Fifth Avenue, S. 6-07 W. 80 feet to the beginning corner."

Being the same premises conveyed to the mortgagors by deed recorded in Volume 324 at Page 396.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
