"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, about six miles from the City of Greenville, known and designated as lot 5, Unit 2 as shown on plat of Pine Crest Farms made by W. J. Riddle, recorded in Flat Book J at Page 47, revised plat recorded in Plat Book M at Page 3, and having according to said plats the following metes and bounds, to-wit:
