NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

H. Harris property, as shown on plat thereof made by R. E. Dalton, Engr., July, 1920, and recorded in the R. M. "BEGINNING at an iron pin on the east side of Georgia avenue at the joint corner of Lots Nos. 3 and 4, which point is 248.4 feet north of the northeast corner of the intersection of Easley Bridge Road and Georgia Avenue, and running thence along the joint line of said Lots Nos. 3 and 4, N. 71-00 E. 177.1 feet to an iron pin on the rightof-way of the P. & N.
