"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Eastern side of Townes Street, in the City of Greenville, being known and designated as the Southern half of lot #41, of Section B, on plat of property of Stane Land Company, recorded in the R.M.C. Office for Greenville County in Flat Book A at Pages 337-345, and also being shown as lot 8A, Block 4, Page 6 of the City Block Book, and being more particularly described by metes and bounds, as follows:
