"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, Greenville Township, being located on the southeastern side of Lady Marian Lane, and being shown as the major portion of Lot 134 on plat of Sherwood Forest recorded in Plat Book "GG" at Pages 2 and 3, and being more particularly described by metes and bounds as follows:

"BEGINNING at an iron pin on the southeastern side of Lady Marian Lane at the joint front corner of Lots 169 and 134 and running thence with the line of Lot 169 S. 22-22 E. 150 feet to an iron pin at the corner of lot heretofore conveyed to Carl W. Sinclair; thence with the lines of the lots of Sinclair and T. D.
