"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of West Washington Street, in the City of Greenville, and described as follows:

"BEGINNING at an iron pin on the South side of West Washington Street, corner of Lot No. 5, as shown on plat made by J. K. Dickson, Surveyor, and recorded in the RMC Office for said County, in Volume LL, Page 60, and running thence with Washington Street N. 50 W. 50 feet to an iron pin, corner of lot of Bessie V.
