That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about one mile North from Chick Springs, lying on the East side of Turrentine Road, being all of lots nos. 22, 23, 24 and 25 on a plat of property made for Mrs. Nellie M. Turrentine by H. S. Brockman, Surveyor, dated July 12, 1948, and having the following courses and distances:-
