"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designs ted as the major portion of lot No. 161, as shown on plat of the property of Central Realty Corporation, recorded in the R.M.C. Office for Greenville County in Plat Book BB at Pages 22 and 23, and being more particularly described according to a recent survey prepared by J.C. Hill, Engineer, February 21, 1955, as follows:
