Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; on the Northwestern side of Hollywood Circle in the City of Greenville, being shown as Lot No. 23 on a plat of Hollywood Subdivision, recorded in Plat Book S at Page 37, and described as follows:

BEGINNING at a stake on the Northwestern side of Hollywood Gircle 217.7 feet Southwest from Spartanburg Street at corner of Lot 24, and running thence with the Northwestern side of said circle S. 51-45 W. 50 feet to a stake at corner of Lot 22; thence with the line of said lot N. 28-15 W. 125 feet to a stake; thence N. 51-45 E. 50 feet to a stake at corner of Lot 24; thence with the line of said lot S. 28-15 E. 125 feet to the beginning corner.
