NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the East side of 9th Avenue in Judson Mills No. 2 Village, being known and designated as Lot No. 1 of Block F as shown on plat of Judson Mills No. 2 Village made by Dalton & Neves, Engineers, in March, 1939, which plat is recorded in the RMC Office for Greenville County in Plat Book K at Pages 1 and 2, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast corner of the intersection of 9th Avenue and an unnamed street, and running thence with said unnamed street, N. 67-14 E. 132.6 feet to an iron pipe, joint rear corner of lots 1 and 16; thence with the rear line of lots No. 14, 15, and 16, S. 8-43 E. 79 feet to an iron pine in the rear line of Lot No. 14; joint rear corner of lots 1 and 2; thence with the line of lot No. 2, 5. 80-46 W. 128 feet to an iron pipe on the East side of 9th Avenue; thence with 9th Avenue, N. 9-14 W. 48.2 feet to the beginning corner.

Being the same premises conveyed to the mortgagors by deed recorded in Deed Book 313 at Page 404.
