NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the south side of Sixth Street in Section 4 of Judson Mills Village, near the City of Greenville, being shown as Lot No. 74 on plat of Section No. 4 of Judson Mills Village, made by Dalton & Neves, Engineers, January 1941, recorded in the R. M. C. Office for Greenville County in Plat Book "K" at Pages 75 and 76, and described as follows:

"BEGINNING at an iron pin on the south side of Sixth Street, joint corner of Lots Nos. 73 and 74, and running thence with line of Lot No. 73 S. 1-42 E. 123.6 feet to an iron pin; thence with rear line of Lot No. 50, N. 88-16 E. 81 feet to an iron pin; thence N. 1-42 W. 123.5 feet to an iron pin on the south side of Sixth Street; thence with the south side of Sixth Street S. 88-20 W. 81 feet to the beginning corner."

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 335 at Page 301.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
