NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of <u>Greenville</u>, in the City of

Greer and Chick Springs Township, located on the East side of North Main Street, being all of Lot No. 3 in Block No. 2 on a plat of property recorded in the R.M.C. Office for Greenville County in Plat Book A, at page 299, and having the following courses and distances:

Beginning on a stake on said street, the northwestern corner of the lot, and runs thence with said street S. 7.25 W. 61.9 feet to a stake; thence S. 82.35 E. 175 feet; thence N. 7.25 E. 61.9 feet; thence N. 82.35 W. 175 feet to the beginning corner, being the identical property conveyed to the late Allen Monroe Green by Harris-Brockman Mfg. Company, by deed dated April 23, 1920, recorded in the R.M.C. Office for Greenville County in Deed Book 53, at page 401.
