"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the Eastern side of Grove Creek, containing 8.41 acres according to plat of the property made by W. J. Riddle, and more particularly described as follows:

"BFGINNING at an iron pin in the center of the Bridge over Grove Creek at the intersection of road from Piedmont to Moonville, and running along the center of said road, N. 73-35 E. 250 feet to point in center of said road; thence continuing along center of said road, N. 58-30 E. 654 feet to a point in center of road; thence N. 38-15 W. 783.5 feet, more or less, to stake on bank of Grove Creek; thence along Grove Creek, 1050 feet to the beginning point."
