the carriage of passengers for hire in the City of Greenville,

South Carolina, and in the vicinity thereof, including but not

being limited to the franchises, rights, privileges and immunities

for such purposes contained in the franchise originally granted

to George M. Bunting, his associates and assigns, by an ordinance

of the City of Greenville ratified on July 14, 1899, as heretofore

modified and amended, and contained in the franchise originally

granted to Southern Public Utilities Company, its successors and

assigns, by an ordinance of the Town of West Greenville ratified

on March 31, 1915, as heretofore modified and amended.
