WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-five Hundred -----

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs...,

Township, on the north side of McDade Avenue and the west side of Finley Avenue in the City of Greer, being Lots Nos. 8 and 8 of the Property of Nancy W. Finley according to survey and plat by H.S. Brockman, Surveyor, dated June 17, 1947, and having the following courses and distances, to wit:

Beginning at a stake at the intersection of Finley Avenue and McDade Avenue, being the southeast corner of Lot No. 3, and running thence along the west side of Finley Avenue, N. 1.10 %. 150 feet to a stake, corner of Lot No. 11; thence S. 80.05 %. 100 feet to a stake, corner of Lots Nos. 9 and 10; thence S. 1.10 F. 150 feet to a stake on north side of McDade Avenue; thence along same, N. 80.05 E. 100 feet to the beginning corner.
