"All that piece, parcel or lot of land in Dunklin Township, Greenville County, State of South Carolina, containing 113 acres, more or less, on waters of Reedy River, bounded by lands of James J. Shumate, milliam Holland, and by heedy River. Beginning at an ash 3x on said river, and running thence S. 78 W. 58.50 to a stone 3x; thence S. 11 W. 4.33 to stone 3x on small branch; thence along meanders of said branch 28,95 to White Oak 3x, on branch of Reedy River; thence with said Reedy River to the beginning corner."
