MORTGAGE OF REAL ESTATE

COUNTY OF Greenville To All Whom These Presents May Concern: I, James Harold Arnold, of Greenville County, WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-VILLE, in the full and just sum of Thirteen Thousand and No/100 - - - - - - - - -(**\$** 13,000.00 .) "BEGINNING at an iron pin on the southeasterly side of LeGrand Boulevard at the joint front corner of Lots 7 and 8, and running thence along the joint line of said lots, N. 88-30 E. 150 feet to an iron pin; thence N. 1-30 W. 68.5 feet to an iron pin on the southerly side of Sharon Drive; thence along the southerly side of Sharon Drive, N. 83-06 W. 50.4 feet to an iron pin; thence continuing with the southerly side of Sharon Drive, S. 88-30 W. 75.2 feet to an iron pin at the intersection of Sharon Drive and LeGrand Boulevard; thence around said intersection on a curve, the chord of which is S. 43-30 W. 35.4 feet to an iron pin; thence along the southeasterly side of LeGrand Boulevard, S. 1-30 E. 53.7 feet to the point of beginning; being the same conveyed to me by John L. Vaughn by deed of even date herewith, not yet recorded."
