NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Grove Township, on the Western side of the Old Grove Road, and being shown as Lot No. 3 on Plat of property of L. A. Mills recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book II, at page 25, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of the Old Grove Road, at the corner of Lots Nos. 1 and 3, and running thence with the line of Lot No. 1, S. 76-36 W. 1824.9 feet to an iron pin; thence N. 4-28 E. 140.4 feet to an iron pin; thence N. 71-15 E. 1781.9 feet to an iron pin on the Old Grove Road; thence with the Western side of said Road, S. 14-53 E. 300 feet to the point of beginning.
