All that certain parcel or tract of land containing Twenty-five and one-half (25½) Acres, more or less, situated on the south side of Rocky Creek, about one mile southward from Pelham, in Butler Township, Greenville County, State of South, and having courses and distances according to survey and plat by H.S. Brockman, Registered Surveyor, dated December 27, 1950, as follows, to wit:
