NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wjt:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern corner of the intersection of Woodland Lane and Piney Ridge Drive, and being known and designated as Lot No. 4 of the property of O. A. Wright as shown on a plat thereof being recorded in the R. M. C. office for Greenville County in Plat Book CC, at page 11, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Woodland Lane, joint front corner of Lots 3 and 4, and running thence with the eastern side of Woodland Lane, N. 47-00 W. 55 feet to an iron pin; thence continuing with Woodland Lane as it intersects with Piney Ridge Drive, following the curvature thereof, the chord of which is N. 2-00 W. 35.3 feet to an iron pin on the southern side of Piney Ridge Drive; thence with the southern side of Piney Ridge Drive, N. 43-00 E. 150 feet to an iron pin, joint corner of Lots 4 and 16; thence with the line of Lot 16, S. 47-00 E. 80 feet to an iron pin, joint rear corner of Lots 3 and 4; thence with the line of Lot 3, S. 43-00 W. 175 feet to the beginning corner; being the same conveyed to me by O. A. Wright and B. C. Willingham by deed dated July 24, 1954 and recorded in the R. M. C. office for Greenville County in Vol. 505, at page 35."
