"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, BEING shown and designated as a portion of lot #11, Section *A", on plat recorded in Plat Book J at Page 151, and being more particularly described by metes and bounds, as follows:

*BEGINNING at an iron pin on the Southern side of Clemson Avenue, at the joint corner of lots 10 and 11, and running thence with line of lot 10, S. 41-20 E. 393.2 feet to an iron pin; thence S. 35-05 W. 67.1 feet to an iron pin at corner of lot heretofore conveyed to Joseph A. Thomas; thence with line of Thomas lot, N. 41-20 W. 399.3 feet to an iron pin on Clemson Avenue; thence with Clemson Avenue, N. 48-40 E. 65 feet to the beginning corner.
