All that piece, parcel or lot of land in Greenville County, State of South Carolina, lying about imile Northwest from the Town of Greer and on the Olf Chick Springs Road, and having the following courses and distances, to wit:

BEGINNING at an iron pin on the North side of said Old Chick Springs Road and runs thence N. 17 E. 350 feet to an iron pin; thence N. 19 W. 91 feet to an oak fence post; thence S. 72 W. 21 feet to a cherry tree; thence S. 17 W. 150 1/3 feet to an iron pin; thence N. 73 E. 62 feet to an iron pin; thence S. 17 W 262 feet to an iron pin on the Old Chick Springs Road; thence N. 86 E. 8 feet to the beginning corner, containing One-fourth (1) Acre more or less, and being the identical lot of land conveyed to J. Langston by S.W. Walker by deed dated November 8, 1935, recorded in the R.M.C. Office for Greenville County in Deed Book 181, at page 479.
