MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, J. E. Childs and Romola L. Childs, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eleven Thousand, Five Hundred and No/100 - - -

(\$\frac{11,500.00}{\text{o}}\) Dollars, or for future advances which may be made hereunder, from time to time, up to and including the maximum amount named herein, such advances to be repaid so as to be completed within the terms of the original contract, and so long as the monthly payments set out in the note are paid according to contract, this loan shall not be deemed delinquent by reason of said advances, with interest at the rate specified in said note,

(the terms of which are incorporated herein by reference) to be repaid in installments of Seventy-Five and 90/100 - - - - - - - - (\$ 75.90) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Wedgewood Drive in Chick Springs Township, and known and designated as Lot No. 3 on plat of Property of R. M. Gaffney and C. E. Robinson, Jr. prepared by Dalton & Neves, Engineers dated July, 1951 and recorded in the R. M. C. office for Greenville County, S. C. in Plat Book "AA", at page 133 plus the lot of land situate immediately east of the aforementioned lot and bounded on the east by a creek, said lots having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northwestern side of Wedgewood Drive, at the joint front corner of Lot No. 3 and a drive in the rear of Lot No. 2, which iron pin is 195 feet in a northwesterly direction from the northeastern intersection of Broughton Drive and Wedgewood Drive, and running thence along said drive and joint line of Lot No. 1, N. 0-37 E. 150.6 feet to an iron pin, joint rear corner of Lots Nos. 1 and 3; thence N. 67-08 E. 150 feet to the center of a creek; thence following the center of said creek as the line in a southerly direction 130 feet, more or less, to a point on the northwestern side of Wedge-wood Drive; thence along the northwestern side of Wedge-wood Drive in a westerly direction 62 feet, more or less, to an iron pin on southwestern corner of Lot No. 3; thence continuing along said Drive, S. 61-04 W. 80 feet to the point of beginning; being the same conveyed to us by Leland Homer Walker by deed of even date herewith, not yet recorded."
