ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate and being on the South side of East Tallulah Drive, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being known as Lot 29 on plat of Property of D. T. Smith Estate, made by Dalton & Neves, Engineers, May 1935, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "H", at page 279, and having, according to said plat, the following metes and bounds, to wit:
