NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greer, Chick Springs Township, located on the South side of Church Street, bounded on the North by said street, on the East by Miss Maggie Harrison, on the South by City of Greer, and on the West by James E. Bennett, having the following courses and distances: BEGINNING on a stake on the Harrison line, and runs thence N.  $30\frac{1}{2}$  E. 200 feet to a stake on Church Street; thence with said street N.  $76\frac{1}{2}$  W. 96 & 1/3 feet to a stake; thence with the Bennett line S. 32.45 W. 200 feet to a stake; thence with the City line S.  $76\frac{1}{2}$  E. 88 & 10/12 feet to the beginning corner, and being all of that lot of land conveyed to the mortgagor by Luta B.
