NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as lot # 16, as shown on a plat of Monaghan Subdivision, recorded in the R. N. C. Office for Greenville County in Plat Book GG at Pages 86 and 87, and being more particularly described according to a recent survey prepared by J. C. Hill as follows:

"BEGINNING at an iron pin in the Northern side of Parker Road, the joint front corner of lots 16 and 17, and running thence with joint line of said lots, N. 30-30 E. 135.8 feet to an iron pin, corner of lot # 15; thence with line of said lot, S. 45-36 E. 142.1 feet to an iron pin in the Western side of Marchant Street; thence with said Street, S. 43-45 W. 97.2 feet to an iron pin; thence with the curve of the intersection of Marchant Street and Parker Road, the chord of which is I. 86-00 W. 36.9 feet to an iron pin; thence with said Parker Road, N. 51-30 W. 105 feet to the point of beginning.
