All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Chick Springs Township near the town of Taylors and being more particularly described as follows:

BEGINNING at an iron pin at the northwest corner of the lot of W. J. Batson in the line of property of Noble Ernest Reese and Gertrude West Reese, and running thence N. 15 ½ W. 10 feet, more or less, to an iron pin on the south side of the right-of-way of Super Highway No. 29; thence along the south side of Super Highway No. 29 approximately N. 60 E. 125 feet, more or less, to an iron pin on the south side of said Super Highway No. 29 at the northeast corner of the property of Noble Ernest Reese and Gertrude West Reese; thence S. 15 3/4 E. 47.5 feet to an iron pin at the northeast corner of the Batson lot; thence along the line of the Batson lot, S. 74 ¼ W. 116 feet, more or less, to the beginning corner.
