NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, sparcels or low of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Douglas Street near the City of Greenville, being shown as Lots 100 and 101 on a plat of property of Eliza T. Looper made by R. E. Dalton in December, 1924, a portion of said plat being recorded in Plat Book "H" at Page 159, and described as follows:

"BEGINNING at a stake on the south side of Douglas Street 150.06 feet west from Looper Street at the corner of Lot 99 and running thence with the line of said lot S. 18-40 E. 148.9 feet to a stake; thence S. 71-20 W. 100 feet to a stake at corner of Lot 102; thence with the line of said lot N. 18-40 W. 151.2 feet to a stake on Douglas Street; thence with the south side of said street N. 72-30 E. 100.04 feet to the beginning corner."
