All that piece, parcel or lot of land, with all improvements thereon, situate, lying and being in Chick Springs Township, said State and County, one mile South of Taylors, on North side of road leading from Taylors-Brushy Creek Road to the Greer-Brushy Creek Road, containing 1/2 acre, more or less, and having the following courses and distances, to-wit:

BEGINNING on a stake in center of said road, said stake being N 70-00 E 70 feet from the Southeast corner of the lot of Elzora S. and William T.
