Lot No. 10: Beginning at an iron pin on the South side of Camille Avenue at the joint front corner of Lots Nos. 10 and 11; thence with the line of Lot No. 11, S. 8-45 W. 144.48 feet to an iron; thence N. 81-15 W. 71 feet to an iron pin, said pin being the joint rear corner of Lots Nos. 9 and 10; thence along the common line of Lots Nos. 9 and 10, N. 8-45 E. 140.12 feet to an iron pin on the South side of Camille Avenue, joint front corner of Lots Nos. 9 and 10; thence along the South side of Camille Avenue, S. 84-50 E. 71 feet to an iron pin at the point of beginning.
