D. Workman as shown on plat thereof prepared by Dalton & Neves, Engineers, August, 1943 and recorded in the R. M. C. office for Greenville County in Plat Book N, at page 113, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Agnew Avenue in the front line of Lot No. 3, which pin is 830 feet, more or less, along Agnew Avenue from the intersection of said avenue with Bramlett Road, said pin being also 25 feet along Agnew Avenue from the joint front corner of Lots Nos. 3 and 4, and running thence along the southern side of Agnew Avenue, S. 66-13 E. 47.5 feet to an iron pin in the front line of Lot No. 4; thence on a line through Lot No. 4, S. 23-47 W. 320 feet, more or less, to a point in Long Branch; thence up the meanders of Long Branch, a traverse line of which is N. 50-53 W. approximately 50 feet to a point in said branch, which point is approximately 25 feet westerly from the joint rear corners of Lots Nos. 3 and 4; thence on a line through Lot No. 3, N. 23-47 E. 310 feet, more or less, to the beginning corner; being a portion of the property conveyed to me by Lee Roy Moody and Minnie Floyd Moody by deed recorded in the R. M. C. office for Greenville County in Vol. 537, at page 198."
