All of that parcel or tract of land in Highland Township of Greenville County, South Carolina, adjoining lands of the Lenoah School, T.A. Lynn, and others, lying on the north side of a road that leads from the Greer-Highland Road by way of Camp Creek Baptist Church to Tigerville, being all of tracts Nos. 10, 11 and a portion of tract No. 9 on plat of the W.W. Davis lands, plat by H.L.
