NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Underwood Avenue in the City of Greenville, being shown as Lot No. 40, Glenn Grove Park, made by R. E. Delton in May, 1924, recorded in Plat Book "F" at Page 233, and described as follows:

"BEGINNING at a stake on the eastern side of Underwood Avenue 83 feet north from Monticello Avenue at corner of Lot 41 and running thence with the line of said lot S. 74-12 E. 150 feet to a stake; thence N. 15-48 E. 50 feet to a stake at corner of Lot 39; thence with the line of said lot N. 74-12 W. 150 feet to a stake on Underwood Avenue; thence with the eastern side of said avenue S. 15-48 W. 50 feet to the beginning corner."
